It's required for local- or state-wide collection monitoring and analysis, and to ensure programs and projects have consistent and complementary objectives. Given the Chief Epidemiologist

establishes policies, protocols, and standards of practice, it's obvious that the datapoints they require must by precise, consistent, up-to-date, and wide reaching.
